Museum Experience programming has replaced our former Museum District Day program. The Museum Experience is a new quarterly block party program intended to give visitors the opportunity to experience all 20 district institutions in an intimate way. These 4 zoned events highlight the programming museums feature every day and are designed to help visitors learn more about the hours, free times, exhibitions, and most importantly, the daily programming that museums make available to them all year long. Museum District Day programming was a part of our service line for 17 years. It was a single day event that featured free admission to all district institutions.

Museum Educators Open House: 5 host museums in the Houston Museum District and other regional museums offer information and presentations to teachers, administrators, and home-schoolers about learning opportunities and assistance for teachers and students. 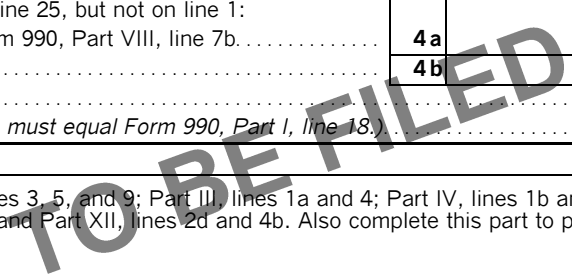
